- This is a family oriented festival. No sexual, racial or adult novelty items are permitted. Any exhibitor in possession of these items will be asked to leave.
- No spray string, pepper spray, fireworks or weapons allowed.
- The festival reserves all rights to use the festival name and logo. Any items with the unauthorized use of either will be removed.
- Photos and or descriptions of items sold may be posted on the Festival's event FB page.
- Motor vehicles may unload in the vendor area but are asked to not move within the vendor area from 10am to 2pm.
- If ALL items are 100% handmade or are bought and then embellished by the vendor it is considered arts and crafts.
- Community organizations must provide a carnival themed game for attendees to play.
- The festival cannot be liable in any way for damage, lost work or injury to persons participation. If insurance is desired it must be secured by the individual vendors. All reasonable care will be exercised.
